

**NOTICE OF FINAL PUBLIC HEARING AND  
DISPLAY OF PROPOSED FIVE YEAR CONSOLIDATED PLAN AND  
FY 2018 ANNUAL ACTION PLAN FOR MILLCREEK TOWNSHIP**

Notice is hereby given by Millcreek Township that a proposed Five Year Consolidated Plan for FY 2018-FY 2022 (July 1, 2018 to June 30, 2023) and FY 2018 Annual Action Plan have been prepared, and the Township intends to apply for \$253,850 in FY 2018 federal Community Development Block Grant funds. In accordance with the federal regulations at 24 CFR, Part 91, Millcreek Township is required to prepare and submit a Five Year Consolidated Plan and Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD) for the Township's housing and community development programs.

**Notice of Display of Plans**

In order to obtain the views of citizens, public agencies and other interested parties, Millcreek Township will place its proposed Five Year Consolidated Plan and 2018 Annual Action Plan on public display for 30 days (from May 24-June 22, 2018) in the following locations during normal operational hours.

The Annual Action Plan contains the following major components:

1. Identification of federal and non-federal resources reasonably expected to be made available during the program year to undertake activities identified in the Five Year Consolidated Plan.
2. A list of activities to be undertaken during the FY 2018 program year to address community development and housing needs.
3. Identification of homeless and special needs activities to be undertaken during the annual program period.

The Five Year Consolidated Plan and FY 2018 Annual Action Plan were developed after conducting a public hearing, gathering information on housing and community development needs from various agencies, human service organizations and other parties, and reviewing funding requests from local organizations/agencies. In addition, the five year housing and community development priorities were developed based on input obtained at the public hearing and during interviews and surveys with local housing and community development stakeholders conducted during the preparation of

the plans. The Township will use the FY 2018 funds in the following manner to address the identified needs within the Township:

### **FY 2018 CONSOLIDATED PLAN FUNDING STRATEGY**

#### **Project Name/Description/Amount**

1. Sidewalk Accessibility Project- Phase VII - Funds in the amount of \$213,850 will be used to continue the township's Sidewalk Accessibility Project through the design, removal and replacement of sidewalk ramps and blended transition areas throughout the township.
2. Senior Center Operational Support Project - Funds in the amount of \$10,000 will be used to support the continued operation of the Regional Senior Center.
3. Administration – Funds in the amount of \$30,000 or 11.8% of the allocation will be used for planning and administrative services provided by the Erie County Department of Planning. Of note, HUD allows up to 20% for administration.

#### **Notice of Public Hearing**

Notice is hereby given that Millcreek Township will hold a public hearing on June 20, 2018 at 10:00 am at the Millcreek Township Municipal Building, 3608 West 26<sup>th</sup> Street, Erie, to obtain final comments on the proposed use of funds. Persons interested in the use of the above identified funding are encouraged to attend the public hearing and provide oral or written testimony. The hearing room is accessible to persons with physical disabilities. The final Five Year Consolidated Plan and FY 2018 Annual Action Plan will be submitted to HUD on or before June 30, 2018.
