2. Millcreek Township demolition permit fee is \$50.00 for residential and \$100.00 for non-residential and can be paid by check or cash. Please make checks payable to Millcreek Township Supervisors.
3. When structure is demolished, you must send a copy of this permit to the Erie County Assessment Office 140 West 6<sup>th</sup> Street, Erie, PA 16501 so that they may correct your assessment records.
